In the documents, all issues subject to the permission for the publication licence must be easily identifiable.
2. If the work is prepared as part of educational classes or the performance of professional obligations during work for a given scientific entity, in particular under the supervision or direction of a scientific tutor, the Author warrants that the publication of the work is without prejudice to the copyrights of the scientific tutor or scientific entity to the work. If the copyrights the work are granted together with the scientific tutor or scientific entity, the Author must submit relevant permissions for granting the licence to the Academy of Fine Arts in Warsaw for the purpose of the publication of the work.
3. If the work is prepared during educational classes or the performance of professional obligations during work for a given scientific entity, in particular under the supervision or direction of a scientific tutor, the Author must submit a publication consent signed by the supervisor (employer) or the scientific tutor being an independent scientific employee.

1. For the purpose of publishing the Article entitled„How to correctly fill a licence?“.....

, including charts, tables, photos, drawings, graphics, lists and other work attached to the Article and forming the integral whole, in number **1** of „ICAR - International Journal of Young Conservators and Restorers of Works of Art“, the Author grants the Publisher, i.e. the Academy of Fine Arts in Warsaw, with a five-years non-exclusive and free licence for the use of the work in the following fields:
- a. the preparation of a digital record of the work;

 - c. the multiplication of the work by the use of printing, electronic and digital techniques, the reproduction, distribution, publication and storage of the work under number **1** of „ICAR - International Journal of Young Conservators and Restorers of Works of Art“ without limitation as to the territory, distribution, time and number of copies;
 - d. trading copies of magazine where the work is recorded and earning financial benefits from the sale of the work under number **1** of „ICAR - International Journal of Young Conservators and Restorers of Works of Art“ by the use of printing, electronic and digital techniques;
 - e. making the Article publicly available to anyone at individually chosen place and time.

§3

The Parties mutually agree as follows:

1. The Editors Office of the Magazine has the right to store the digital record of the final version of the work accepted for publication in number 1 „ICAR - International Journal of Young Conservators and Restorers of Works of Art” for the purpose of the publication of the work in the second and subsequent volumes of the number for up to 12 months of the publication of the first volume of the number.
2. The Author has the right to apply for updating data contained in the work delivered to the Editorial Office of the Magazine till the work publication date. A consent for modifications at the Author’s request will be issued by the Chief Editor on a case-by-case basis based on the application date and the Magazine number publication stage.
3. The Author has the right to make corrections and modifications in the Article and attached work sent to the Editorial Office on the basis of suggestions made by reviewers, members of the Scientific Council of the Magazines and proofreaders within the period set by the Editorial Office of the Magazine.
4. Under the licence granted to the Academy of Fine Arts in Warsaw, if the Article is published, the Author(s) agree(s) that the work attached to the Article may be used for the purpose of the non-commercial educational activity of the Academy of Fine Arts in Warsaw.
5. This licence comes into force provided that the Chief Editor makes a decision on the publication of the work in number 1 of „ICAR - International Journal of Young Conservators and Restorers of Works of Art” in the paper and digital form.
6. The Author is solely liable for the violation of proprietary copyrights to the Article and attached work and commits himself/herself to pay for all and any damage arising from the violation of copyrights of other entities as a result of their use in the Article.
7. The Authors commits himself/herself to meet, on his/her own account, all third party claims connected with the violation of copyrights of third parties or, if the claims are met by or are charged on the Academy of Fine Arts in Warsaw, to reimburse the Academy of Fine Arts in Warsaw with all claims paid and all related expenses,
